#### Motion for a WCA Governance Review of and vote to Proceed with Governance Analysis August 16, 2020

A WCA Governance Review is proposed to assess options for enhanced effectiveness and transparency of the Waterford Citizens' Association (WCA) organizational structure, its relationships with County, State and private utilities and other service providers, as well as other local and regional non-profit organizations.

A proximal reason for this review is increased activity of these service providers in the Waterford Area (e.g., VDOT, Dominion, Loudoun Water) due to growth in Loudoun County, as well as new service needs in the village (e.g., traffic management, water supply). The broader context is Waterford's dual nature as both a residential village and a national historic landmark (NHL). A further factor is the ongoing Covid-19 pandemic, as well as protests in support of greater racial equality, which have created societal disruptions and challenges, but also opportunities and possibilities (e.g., increased number of visitors to the village to enjoy Phillips Farm; Second Street School & John Wesley Church education opportunities; new ways of interacting online; potential interest in Waterford's unique history in the NHL's 50<sup>th</sup> year). These factors suggest that exploring modernization of WCA governance is timely.

The Review would examine:

- (i) the range of services in the common interest now provided, or needed, in the Village;
- (ii) the most appropriate, effective role for the WCA as a public counterpart for each service;
- (iii) how short-term mandates of WCA Officers and many Committees can best address longer term challenges and the need for long-term relationships;
- (iv) ability of WCA membership (or residents) to vote for all board members;
- (v) capacity of WCA to represent the views of Village residents, not just WCA members; and
- (vi) what if any changes might be needed to the WCA's organizing structure, including its Bylaws, to address these issues. The review should make specific recommendations.
- (vii) are other structures (eg incorporation of the Village) better suited address these challenges.

The overall goal is to ensure that the WCA lives up to its mandate to "to foster community action, to further the common good and general welfare of the community, to secure improvements, and to maintain the Waterford Area as a desirable and attractive community in which to live" (Preamble to WCA Bylaws).

This is envisioned as a desk review to be augmented by interviews. The time-frame for carrying out the review would be approximately three months, with recommendations presented to the WCA Board and discussed by the membership and residents before the end of 2020.

The Members discussed the Governing Motion for Ad Hoc Committee, to create a Scope of Task and determined the following: <u>Governance Committee Scope of Task</u>

Cate Magennis Wyatt offered a motion, seconded by Mary Sheehan, to approve the Minutes of October8th Meeting. The motion passed unanimously.

The Following Actions Steps were decided upon:

## **Bylaws:**

Cate will create a redline/decision point copy of the Bylaws for collective review. Cate will reach out to Christy Hertel to obtain copies of standard HOA governing documents.

## WCA Functions:

Mary will flesh out thoughts on the WCA Functions and recommend structuring the Standing Committees to reflect these Functions. In this effort Mary will identify which "tools" and potential Partners are available to each Standing Committee.

## The Vision:

Mike Stup's recommendation to structurally incorporate into the WCA's governance and ongoing operations the means to envision what the citizens want Waterford to be in twenty years, was discussed. Cate suggested bringing all past plans together to both ensure the WCA has an archive of studies done, but also to use as a basis for planning a series of meetings open to all citizens and in conjunction with the WFI, to ask "What do We Want Waterford to be in 20 Years?"

Mary offered to reach out to Stephanie Thompson, Executive Director of the WFI, and WCA member Nick Ratcliffe for past studies. Cate will ask Meredith Imwalle for the most recent VDOT studies as well.

Cate offered to set up a meeting with the President of the Waterford Foundation and Ray Daffner, President of the Waterford Citizen's Association to determine if both organizations are interested in pursuing this collective visioning effort, and if so, what type of standing committee would they envision within their governing documents.

Finally, Mary offered to ask around to see if we could obtain pro-bono services of a land planner to assist this effort.

Also, i had a rather long an productive meeting with Al earlier this week. **Great!** While he wasn't able to give us a comparable governing structure, he did encourage us to participate in the current effort to update the Loudoun Zoning code. To that end i have a note to Maura Welsh Copeland, who serves on that committee, to chat. I'd like to invite her to our next meeting if you all agree. **Yes, I agree.** Maura will be a truly excellent resource. She is

## extremely knowledgeable, and may likely get into the details. So we may end up having time only for that topic...?

I have also reached out to the WFI to see if they have ever exercised their review and consultation authority under Section 106 when VDOT makes plans to "improve" the streets of Waterford. This could be an excellent tool for a joint WCA/WFI committee. This is a superb and useful insight. Potentially very helpful to pursue this. We in Traffic Committee have had such difficulty convincing VDOT of special historic status of NHL and need for historic-specific solutions (consultants themselves are more aware). I am curious, what legal grounding gives WFI their Section 106 review and consultation authority? Is there a legal way WCA (or some partnership between the two organizations) could share in that authority? I ask because the WCA, representing residents who are each also NHL stewards of the private homes, has substantial interest in the potential modern intrusion of infrastructure such as traffic and power poles.

Incorporation Option: Mike offered to get the 2016 summary documents from Sharyn for our discussion

5. Loudoun Villages: I did have an opportunity to have an impromptu conversation with Richard Rogers. His observations regarding the Loudoun Villages very much mirror Al's observations; evidently, we are the leaders of the pack as the others are only now filing for Non-Profit status so they can create a more structured governing system. Having said that, Richard is very open to participating in one of our meetings to see how we might further support this effort and vise-versa. **Super, I'll follow up also.** 

6. NHL: SPOT ON!!! We (WCA and WFI) needs to create and institutionalize a committee, to educate all citizens, committee members, elected officials, utility companies and governmental agencies (VDOT, Loudoun Water, etc) that the NHL status elevates the assets within its boundaries to an entirely different set of rules and to enforce those rules rigorously. Brown Morton (who wrote them) would be the perfect place to start. **Yes!! Great, look forward to talking further on this.**

Importantly, in addition to the "functional duties" of typical municipalities, this exercise will consider the means of creating a governance structure to ensure the citizens of Waterford have an underlining vision for our future and the means to control our destiny as we move into it. In this, the governance structure may include such committees as an "Idea Exchange", or a "WCA/WFI Innovations Committee" which could embrace the 1987 Waterford Area Management Plan and expand upon it to create future cultural/educational/social enterprises, or even a "What Unites Us and Excites Us" annual visioning, etc.

There being not further business the meeting was adjourned.

Due to the nature of non-profits and volunteer organizations, the good work of one era can unfortunately be duplicated by a following era due to the lack of an organizational governing structure, with a centralize archive and dedicated Joint WFI/WCA Standing Committee to ensure the plans we want are implemented.

#### **Existing Conditions:**

The WCA is in the process of examining and updating its governing documents to address the shifting roles and responsibilities it has assumed, in particular regarding village infrastructure such as traffic and water, in addition to its historically Social and Beautification initiatives.

#### **Recommendation:**

#### extremely knowledgeable, and may likely get into the details. So we may end up having time only for that topic...?

I have also reached out to the WFI to see if they have ever exercised their review and consultation authority under Section 106 when VDOT makes plans to "improve" the streets of Waterford. This could be an excellent tool for a joint WCA/WFI committee. This is a superb and useful insight. Potentially very helpful to pursue this. We in Traffic Committee have had such difficulty convincing VDOT of special historic status of NHL and need for historic-specific solutions (consultants themselves are more aware). I am curious, what legal grounding gives WFI their Section 106 review and consultation authority? Is there a legal way WCA (or some partnership between the two organizations) could share in that authority? I ask because the WCA, representing residents who are each also NHL stewards of the private homes, has substantial interest in the potential modern intrusion of infrastructure such as traffic and power poles.

5. Loudoun Villages: I did have an opportunity to have an impromptu conversation with Richard Rogers. His observations regarding the Loudoun Villages very much mirror Al's observations; evidently, we are the leaders of the pack as the others are only now filing for Non-Profit status so they can create a more structured governing system. Having said that, Richard is very open to participating in one of our meetings to see how we might further support this effort and vise-versa. **Super, I'll follow up also.** 

6. <u>Discussion on the merits of alternative organizational structures: HOAs</u> Mary Sheehan circulated and then presented her research on the governance structure of Home Owner Associations (HOA), which is attached. The members then discussed elements of the HOA governance structure that parallel the WCA Bylaws, for example the Loudoun Historic Review Committee acts very much like an HOA's Covenants, Conditions and Restrictions Committee.

The members then discussed elements of the HOA governance structure the WCA could benefit from, for example: a clear definition of Membership, establishment of voting rights, determination of whether minimum dues are suggested or required and the setting of terms for all officers to enhance succession planning.

#### Hi Ray,

So hope this finds you well and able to enjoy a run during these beautiful days.

Your Ad Hoc Governance Committee has been meeting weekly and are at a place when it's worth our collective time to meet and to review preliminary findings and to ensure we are heading in the right direction. Can you join our scheduled zoom meeting Thursday the 12th at 4pm?

We've approached the task of reviewing and recommending updates to the WCA Governing Documents with Board Hygiene in mind  $\sim$  and the rather simple approach of asking Who? What? Where? When? Why? and How?

#### Who is the WCA Membership?

The **first attachment** is a quick analysis of what has defined "Who can become a WCA Member", upon paying dues and who can vote on matters of concern to the WCA.

This analysis then includes draft alternative means to define the current "Geographic means of defining 'Who' can become a WCA Member" with a suggestion of "weighting" the voting categories of membership ~ clearly incomplete thought process, but worth thinking through with you.

#### What is the WCA?

Based upon the WCA Mission Statement, the WCA Bylaws list the Standing Committees necessary to govern and uphold its Mission. Unfortunately, the Bylaws' definition of Standing Committees are at odds with the list of Standing Committees on the WCA Website. This could be easily cleaned up with this **second attachment**, a simple Decision Point Matrix which reveals both simple discrepancies.

However, Mary has done an outstanding analysis, **the third attachment** and found that, over time the WCA has evolved from an organization focused on villagers celebratory and beautification initiatives into one that, by any other definition, has the responsibilities often attributed to that of a small municipality or Homeowners Association.

To address this evolution of "What is the WCA", our committee has analyzed alternative governing structures, including reincorporation as a small municipality or creating an HOA governing structure and at this time, cannot recommend either. However, we are investigating means to have enabling legislation from the General Assembly to permit the Loudoun Board of Supervisors to grant the WCA in conjunction with the WFI both the Authority to create and the means to enforce all future "Public Improvements" with the Waterford Historic Landmark ~ needless to say, no further steps will be taken without guidance from your Board and the WFI.

#### Where does the WCA want to be?

Given the findings outlined above, our Ad Hoc Governance Committee suggests for your consideration and that of your Board, the creation of a Joint Ad Hoc WCA/WFI "Waterford 2040" vision and planning committee, and creation of a Joint WCA/WFI Waterford 2040 Standing Committee. The reasons behind this research are outlined in the **forth attachment**.



## WCA Governance Review Draft Working Summary of Challenges and Recommendations

Waterford is an unincorporated rural village of Loudoun County and as such does not have an elected local government. The Waterford Citizen's Association (WCA) fills the role of local governance, representing the common and shared interests of the private citizens of the village.

The WCA was established 1954 to support the citizens of the Waterford School District "... to foster community action, further the common good and general welfare of the community, secure improvements, and maintain ... Waterford ... as a desirable and attractive community in which to live..."

With growth in commuter cut-through traffic, increasingly precarious water supply and other emerging challenges, the WCA's role in "securing improvements" – the classic public-good function of village planning and arranging for core services – has grown substantially in the last decade.

Meanwhile, the need for a mechanism for collaborative stewardship of Waterford's unique National Historic Landmark (NHL) designation in light of these challenges among owners of the village's historic properties -- whether private citizens or the Waterford Foundation (WF) -- is increasingly apparent.

The Governance Committee identified three current WCA governance challenges:

- 1. **Who** is the WCA? Examining the boundaries and membership of the WCA and whether changes to ensure it is suitably organized and mandated to fulfill the functions it currently carries out;
- 2. What is the WCA? Determining the most efficient and effective institutional arrangements to meet growing need to ensure the "common good and general welfare" through improved village planning and "securing improvements;" and
- 3. Where does the WCA want to be and How to get there? Identifying citizens' medium-term future vision of Waterford as a "desirable and attractive community in which to live" including appropriate arrangements for cooperative stewardship of the NHL and the policy tools needed.

## WCA Ad Hoc Governance Committee Update on Committee's Work – December 10, 2020 WCA Meeting

A WCA Ad Hoc Governance Committee was constituted in September 2020, under terms of reference dated August 16, 2020, to conduct a WCA Governance Review. The Review was to be carried out via desk research and expert interviews, with a final report provided by end-December 2020. The Committee's members are Cate Magennis Wyatt (chair), Mike Stup and Mary Sheehan.

The Committee was tasked with making recommendations for consideration of the WCA Board and membership to enhance efficiency and effectiveness of the organization in meeting its overarching goal "to foster community action, to further the common good and general welfare of the community, to secure improvements, and to maintain the Waterford Area as a desirable and attractive community in which to live" (Preamble to WCA Bylaws). Specifically, the scope of the Committee's work centered on examining WCA Bylaws and functions and how these are carried out, including arrangements for interacting with WCA County, State and other public service providers (transport, water, electricity); as well as with the Waterford Foundation (WF) on preservation of the National Historic Landmark (NHL).

The Ad Hoc Committee has focused its work in three broad areas:

- Consistency of WCA Bylaws provisions and Committee structures with actual current practice and needs of the WCA. For example, over the years the WCA has evolved from an organization focused largely on community events and initiatives into one that has de facto responsibilities often attributed to a small municipality or Homeowners Association (e.g., traffic management planning). The group has examined the options of both town incorporation and use of HOA type arrangements and will not recommend either option. Rather, the Committee is examining various potential amendments to WCA Bylaws and Committee structures that would provide greater flexibility and responsiveness to reflect current WCA challenges and responsibilities.
- 2. The future of a historically-protected vibrant Waterford village in the medium term, including enhanced collaboration between the WCA and WF toward this goal. The preservation of the NHL rests on the ability of the WF and WCA to collaboratively carry out preservation and conservation the WF for historic structures and spaces it owns or has under easement, and the WCA for citizens' private historic homes and open spaces. The Committee has examined and will be recommending various options for launching a "Waterford 2040" visioning exercise building on and updating the 1987 Waterford Area Management Plan that would set out concrete planning parameters for the next two decades. The Committee will recommend this effort be carried out in a collaborative way with the WF, via a Joint WF/WCA Waterford 2040 Working Group.
- Regarding other topics including WCA membership and boundary definitions, options for possible delegated planning authority, collaboration with the Loudoun Historic Villages Association and other Loudoun County preservation and conservation efforts – the Committee is actively working to further develop recommended options for consideration. These will be made as part of its final end-December report.

## WCA Ad Hoc Governance Committee Update on Committee's Work – December 10, 2020 WCA Meeting

A WCA Ad Hoc Governance Committee was constituted with the September 24, 2020 membership meeting (under terms of reference dated August 16, 2020), to conduct a WCA Governance Review. The Committee's members are Cate Magennis Wyatt, Mike Stup and Mary Sheehan.

The Committee was tasked with making recommendations for consideration of the WCA Board and membership to enhance efficiency and effectiveness of the organization in meeting its goal "to foster community action, to further the common good and general welfare of the community, to secure improvements, and to maintain the Waterford Area as a desirable and attractive community in which to live" (Preamble to WCA Bylaws).

Specifically, the scope of the Committee's work centers on examining WCA Bylaws, committees, and current practices; and also includes evaluating arrangements for interacting with County, State and other public service providers, as well as collaboration with the Waterford Foundation (WF) on preservation of the National Historic Landmark (NHL).

The Ad Hoc Committee is wrapping up its desk research and interviews, with a final report to be provided by end-December 2020. Recommendations are being pursued in the following areas:

- Ways to enhance the consistency of WCA Bylaws provisions and committee work with current needs, and to ensure longer-term institutional sustainability.
- Options for enhancing the role of village entities in local planning to increase responsiveness to current challenges, including a possible update to the 1987 Waterford Area Management Plan.
- Avenues for closer collaboration between the WCA and WF toward historic protection and conservation of the NHL while promoting livability in Waterford village.
- Alternatives to identify and build on areas of common interest across Western Loudoun County's historic villages as they manage similar challenges.
